All inspections are required to be performed and a Certificate of Occupancy and/or Certificate of Approval is required to be issued. This shall be strictly enforced. These inspections shall be performed before the Smoke Detector Inspection is performed. Also, **you are required to have a street number affixed to the house** which should be a minimum height of 2 ½ inches and placed in a conspicuous location and plainly visible from 50 feet away. Any home built after 2017 shall require a 4 inch number.

*****For Hardwired/Wireless – smoke detectors must be certified letter/report from either an alarm company (if monitored) or an electrician stating the smoke detectors have been teste and are in working order & smoke heads are less than 10 years old. All battery powered detectors must be less than 10 years old. The battery must be a 10 year battery.**

You are required to have one (1) Smoke Detector on each level (including basement) and one (1) outside each of the sleeping area(s). No sleeping area(s) are permitted in basement or attic.



You are required to have at least one (1) hard-wired, plug-in and/or battery powered type of Carbon Monoxide Detector within the residence. The unit(s) shall be installed in accordance with the manufacturer's instructions.

You are required to have a fire extinguisher installed. See reverse side of sheet for instructions:

One & Two Family Homes Certification Criteria For Smoke & Carbon Monoxide Detectors

Built Before 1977

Battery Detectors
One on each level

Built 1977 or After, But Before 1984

Electric Detectors not interconnected
Within 10 ft of each bedroom

Built 1984 or After, But Before 1990

Electric Detectors Interconnected
Within 10 ft of each Bedroom

Built 1990 to Present

Electric Detectors with battery back-up-All interconnected
One on each level
Within 10 feet of each bedroom
In each bedroom

Note: Only homes built before 1977 need to have the smoke detector at the bottom of the stairwell in basement
