## SECTION 2 - POPULATION AND SOCIO-ECONOMIC DATA

### Population

The Township of Cedar Grove has grown from a community of 2,139 people in 1900 to 12,411 people in 2010. The population estimate for 2019 was 12,549 persons. The population rate of increase was substantial from the 1930s through the 1960s. The Township experienced population increases of 50 percent in the decade that ended in 1930, 50 percent in the decade that ended in 1950 and 82 percent in the decade that ended in 1960, while the county's population grew at a much slower pace. The Township of Cedar Grove has experienced a decrease in population from 1980 through 1990. From 1900 through 1970, population of Cedar Grove has accounted for a larger portion of the County's population, from 0.60 percent of the total population in 1900 to 1.67 percent in 1970. Since 1970 the population of Cedar Grove, although growing, has stabilized as a percentage of the County population around 1.55 percent.

## Births and Deaths

The number of births and deaths in a community is one component in determining the natural increase or decrease in the overall size of the community. The number of births and deaths are also an important element for determining community facility needs and services, particularly in the school system. The number of births and deaths listed below represent the most current data available from the New Jersey Department of Health from 1990 through 2018. The number of births peaked in 139 in 2006 and 2018, and deaths peaked in 221 in 2008. The Township is experiencing an aging population where the deaths have outnumbered the births for the 14 years that both statistics are available.

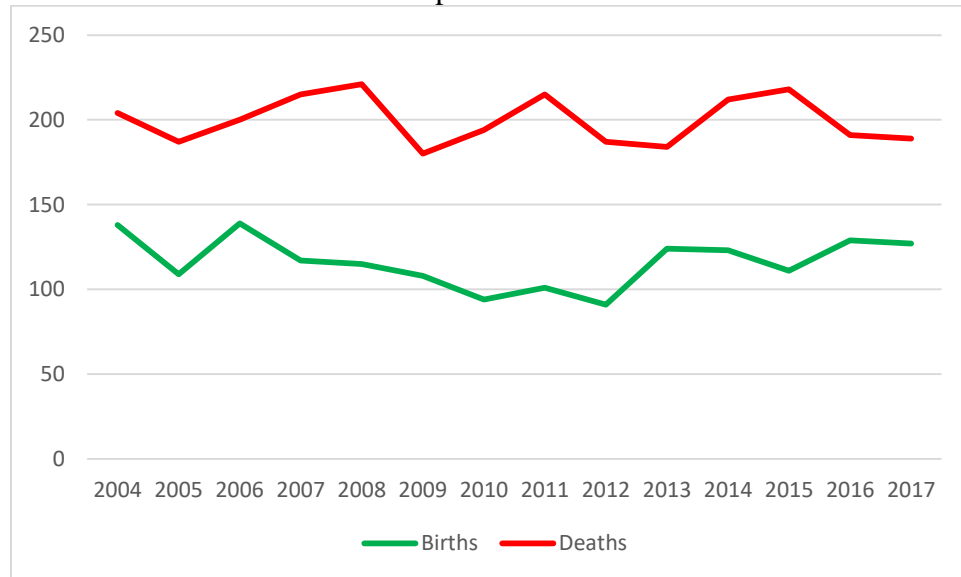

### Migration

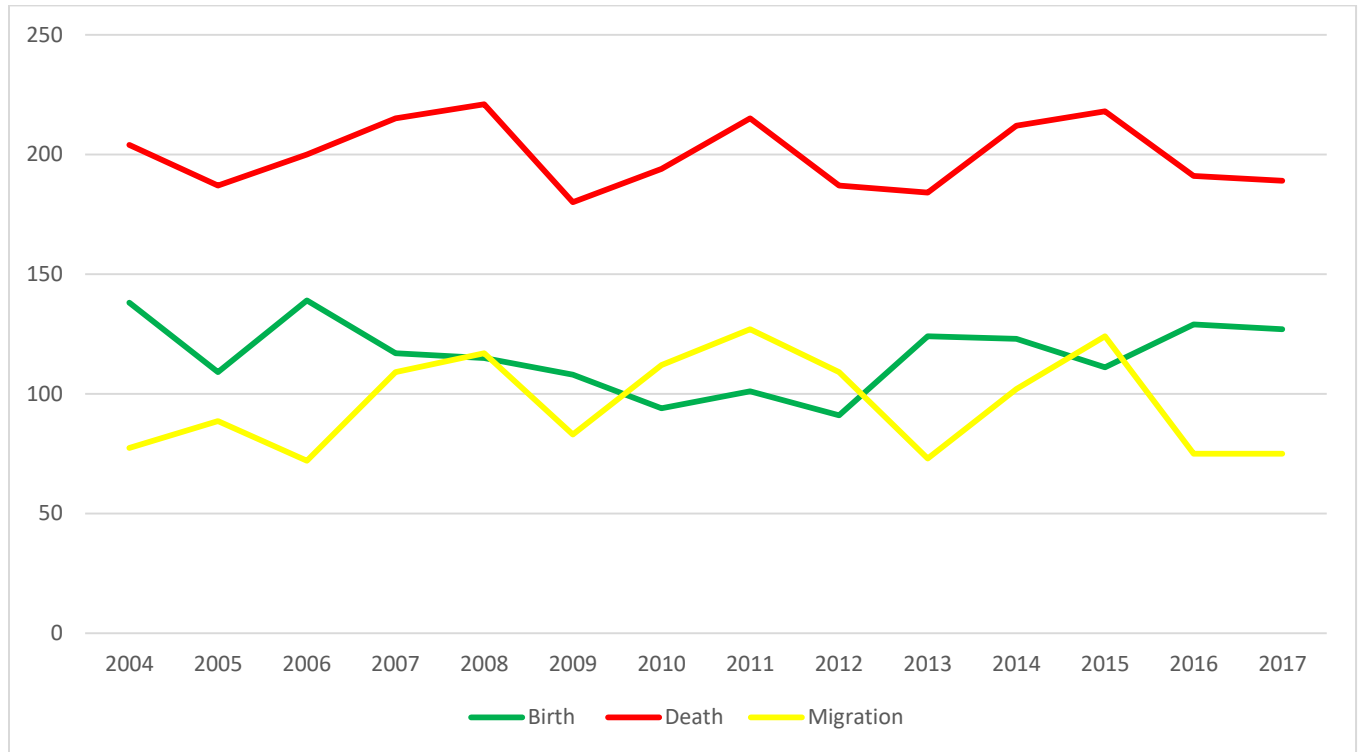
Net migration indicates the number of people moving into or out of a given area. Migration statistics are based upon the estimated population change minus the natural growth rate. Since the Census of Population is only taken once a decade, years between censuses are estimated and are only utilized to illustrate overall trends and not individual yearly data. The data suggests that Cedar Grove experienced “in migration” for the years of 2004 and 2017. This “in migration” off sets the continuous negative growth of the municipality.

Township of Cedar Grove

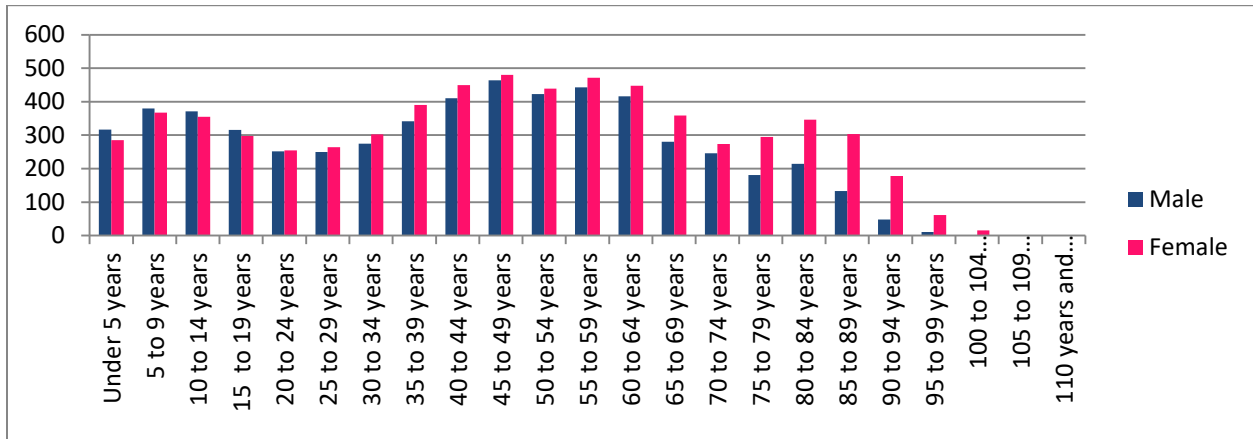
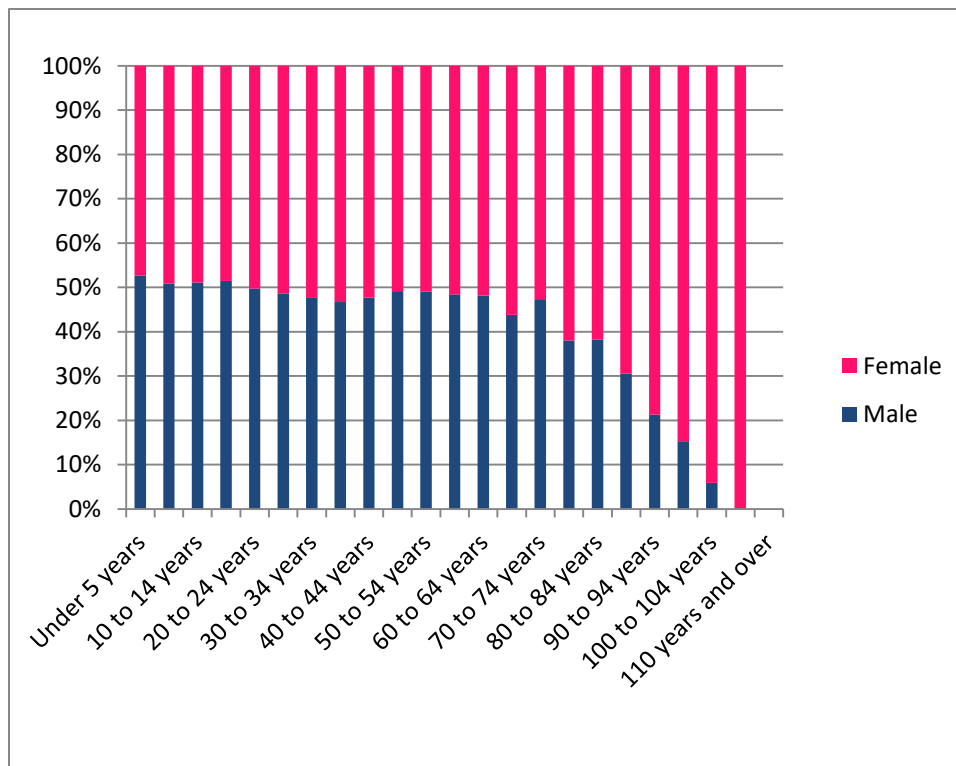


Chart 2 – 4 : 2010 Age Cohorts by Sex as Percentage

## Racial Composition

The Township of Cedar Grove is predominantly white and has been steady from 90 percent of the population in 2000 to 89 percent in 2010. The black or African American population experienced a slight decreased in the ten-year period from 3.0 percent of the population in 2000 to 2.5 percent in 2000. The Asian population grew from 5.4 percent of the population in 2000 to 6.5 percent in 2010.

## Household Income

The Census of Population defines a household as follows:

Households consist of all people who occupy a housing unit. The Census Bureau regards a house, an apartment or other group of rooms, or a single room as a housing unit when it is occupied or intended for occupancy as separate living quarters: the occupants do not live and eat with any other people in the structure and there is direct access from the outside or through a common hall.

A household includes the related family members and all unrelated people, if any, such as lodgers, foster children, wards, or employees who share the housing unit. The Census Bureau also counts a person living alone in a housing unit or a group of unrelated people sharing a housing unit as partners as a household. The count of households excludes group quarters.

Table 2 - 9 indicates the total household income distribution for the years from 2010 through and 2017 for the Township of Cedar Grove's residents. The median household data for the Township, also based upon sample data, was reported to be \$115,926 in 2017 up from \$95,152 in 2010; representing a 21.8 percent increase.

Table 2 - 10 indicates the owner occupied household income distribution for the years from 2010 through and 2017 for the Township of Cedar Grove's residents. The median household data for the Township, also based upon sample data, was reported to be \$133,876 in 2017 up from \$102,500 in 2010; representing a 30.6 percent increase.

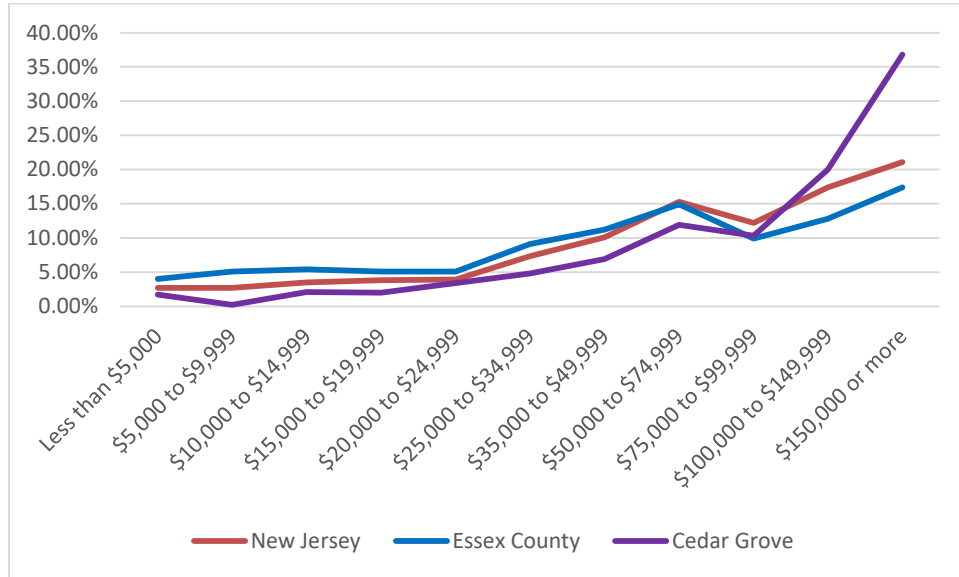

They do not include same-sex married couples even if the marriage was performed in a state issuing marriage certificates for same-sex couples. Same-sex couple households are included in the family households category if there is at least one additional person related to the householder by birth or adoption. Same-sex couple households with no relatives of the householder present are tabulated in nonfamily households. "Nonfamily households" consist of people living alone and households which do not have any members related to the householder.

## Household Size

## Group Quarters

Group Quarters are places where people live or stay, in a group living arrangement, which is owned or managed by an entity or organization providing housing and/or services for the residents. This is not a typical household-type living arrangement. These services may include custodial or medical care as well as other types of assistance, and residency is commonly restricted to those receiving these services. People living in group quarters are usually not related to each other.

Group quarters include such places as college residence halls, residential treatment centers, skilled nursing facilities, group homes, military barracks, correctional facilities, and workers' dormitories.

Group quarters are categorized into two groups, institutional and non-institutional quarters.

**Institutional Group Quarters:** Includes facilities for people under formally authorized, supervised care or custody at the time of interview, such as correctional facilities, nursing facilities/skilled nursing facilities, in-patient hospice facilities, mental (psychiatric) hospitals, group homes for juveniles, and residential treatment centers for juveniles.

**Non-institutional Group Quarters:** Includes facilities that are not classified as institutional group quarters, such as college/university housing, group homes intended for adult, residential treatment facilities for adults, workers' group living quarters, and religious group quarters.

## 2010 Census Tracts and Block Groups

The census defines a census tract as follows:

Census Tracts are small, relatively permanent statistical subdivisions of a county or equivalent entity that are updated by local participants prior to each decennial census as part of the Census Bureau's Participant Statistical Areas Program. The Census Bureau delineates census tracts in situations where no local participant existed or where state, local, or tribal governments declined to participate. The primary purpose of census tracts is to provide a stable set of geographic units for the presentation of statistical data.

Census tracts generally have a population size between 1,200 and 8,000 people, with an optimum size of 4,000 people. A census tract usually covers a contiguous area; however, the spatial size of census tracts varies widely depending on the density of settlement. Census tract boundaries are delineated with the intention of being maintained over a long time so that statistical comparisons can be made from census to census. Census tracts occasionally are split due to population growth or merged as a result of substantial population decline.

Census tract boundaries generally follow visible and identifiable features. They may follow nonvisible legal boundaries, such as minor civil division (MCD) or incorporated place boundaries in some states and situations, to allow for census-tract-to-governmental-unit relationships where the governmental boundaries tend to remain unchanged between censuses. State and county boundaries always are census tract boundaries in the standard census geographic hierarchy.

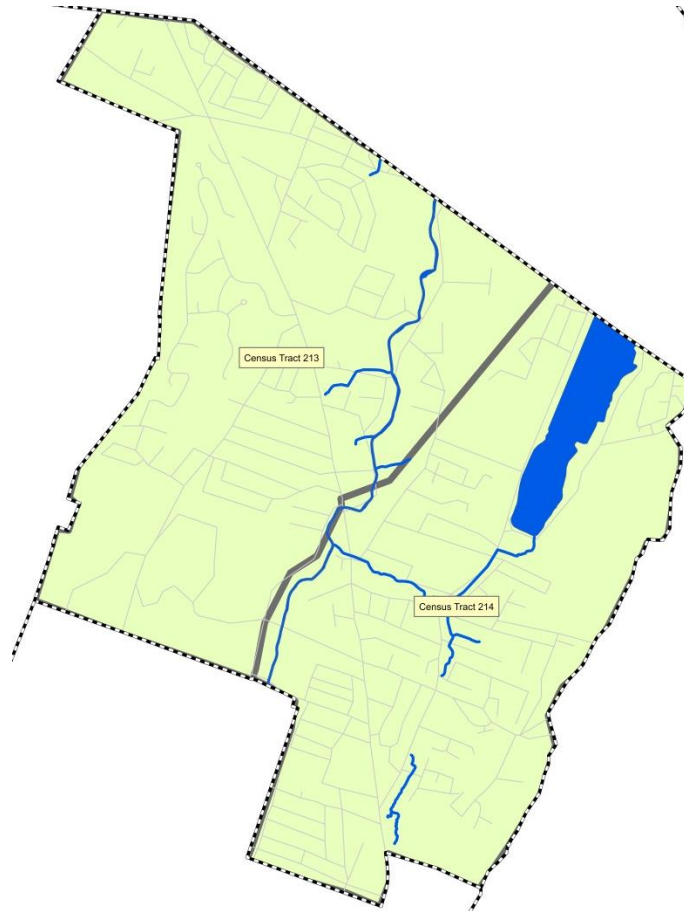
The census defines a census block group as follows:

Block Groups are statistical divisions of census tracts, are generally defined to contain between 600 and 3,000 people, and are used to present data and control block numbering. A block group consists of clusters of blocks within the same census tract that have the same first digit of their four-digit census block number. Most BGs were delineated by local participants in the Census Bureau's Participant Statistical Areas Program. The Census Bureau delineated BGs only where a local or tribal government declined to participate, and a regional organization or State Data Center was not available to participate.

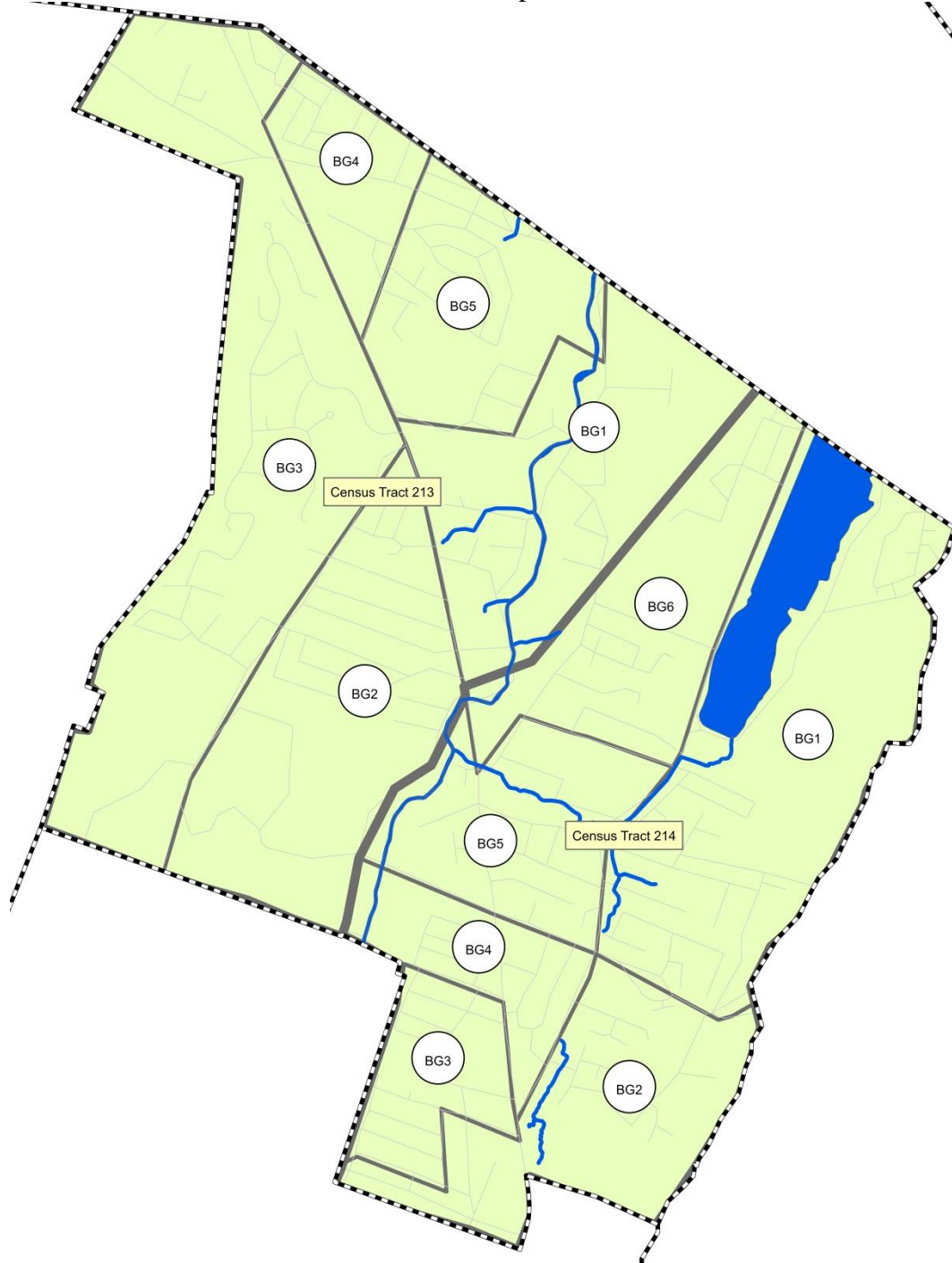
A BG usually covers a contiguous area. Each census tract contains at least one BG, and BGs are uniquely numbered within the census tract. Within the standard census geographic hierarchy, BGs never cross state, county, or census tract boundaries but may cross the boundaries of any other geographic entity.

### Census Tract 213



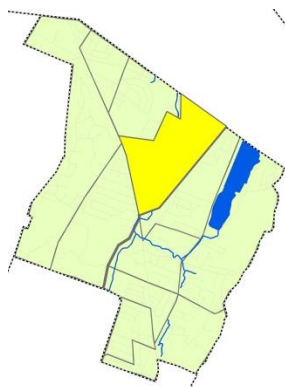
Census tract 213 is located along the western side of the Township. Tract 213 abuts Little Falls to the north, North Caldwell to the west and Verona to the south. Tract 213 is separated from Tract 214 to the east at the southern boundary north along Grove Avenue to the Peckman River, then north along the railroad right of way to its intersection with the municipal boundary to north. Census tract 213 contains 2.31 square miles (1,477.8 acres) and represents 54.31 percent of the municipality.

Census tract 214 is located along the eastern side of the Township. Tract 214 abuts Little Falls to the north, Montclair to the east, and Verona to the South. Census Tract 213 - Block Group 1



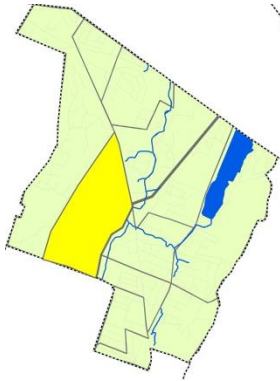

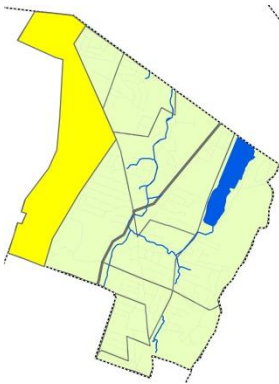

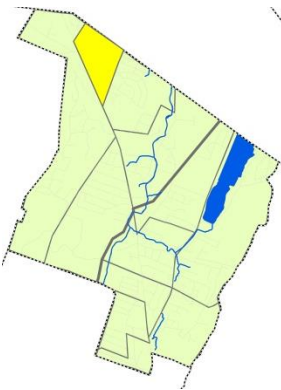
