All Generators must be approved by the Zoning Officer

Any Zoning requirements regarding a generator, portable or permanent (setbacks, fencing & shrubbery) can be addressed by contacting the Zoning Dept. at (973) 239-1410 ext. 280

The Building Department requirements are as follows:

- 1. A copy of survey showing location of generator
- 2. Generator specifications (Spec Sheet with Clearances)
- 3. Must show sound output decibel rating
- 4. Construction permits must include;
 - Zoning Application
 - Electric Sub code
 - Mechanical Sub Code
 - Plumbing Sub code
 - Riser Diagram
- 5. PSEG must be contacted by the contractor or home owner for gas load data inquiry. This information is available on the PSEG website at www.pseg.com/service. You may complete the form and fax it directly to PSEG at (908) 497-1762.

The Building Department in the Township of Cedar Grove is not responsible for any expenses incurred by PSEG. It is the responsibility of the home owner or contractor to submit any paperwork associated with the installation of a generator.
