SEPTEMBER 14, 2020

1. ROLL CALL, INVOCATION AND FLAG SALUTE

Mayor Peterson called the meeting to order at 7:00 p.m.

Present: Councilmen Cicala, Maceri, Zichelli, Deputy Mayor Tanella, Mayor Peterson Also Present: Township Manager Tucci, Township Attorney Semeraro, Township Clerk Stutz

The flag salute was led by Mayor Peterson.

Mayor Peterson made the required announcement concerning the Open Public Meetings Act as follows: Adequate notice of this meeting was duly provided to the Verona-Cedar Grove Times and the Star Ledger on December 26, 2019, updated on September 9, 2020, filed with the Township Clerk, and posted on the public bulletin board in the Municipal Building Lobby in accordance with the Open Public Meeting Act.

2. EXTRAORDINARY BUSINESS – Mayor Peterson stated that there was no extraordinary business.

3. APPROVAL OF MINUTES

a) To consider approval of minutes of reorganization meeting of July 1, 2020

4. AWARD OF BID

a) To consider resolution awarding bid for Locker and Bathroom Alterations & Additions to Police Department

The following resolution had been posted on the bulletin board, and a brief synopsis was given by the Township Clerk:

WHEREAS, the Municipal Engineer and Township Attorney have reviewed the bids submitted, and recommend that the award of bid to Ranco Mechanical LLC of Newton, New Jersey, the apparent low bidder, in the amount of \$ 148,900.00; and

WHEREAS, the funds are available to satisfy our obligations under this contract from Bond Ord. 19-841 and Bond Ord. 20-856.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Cedar Grove, that the award of bid be made to Ranco Mechanical LLC of Newton, New Jersey.

BE IT FURTHER RESOLVED that the proper officials be instructed to execute a contract on behalf of the Township.

5. MEETING OPEN TO RESIDENTS OF THE TOWNSHIP WISHING TO BE HEARD ON ANY ITEM ON THE AGENDA

Mayor Peterson opened this portion of the meeting to anyone wishing to be heard on any item on the agenda. There being no one present wishing to be heard, Mayor Peterson closed this portion of the meeting.

6. REPORTS OF TOWNSHIP OFFICIALS

- a) Township Manager The Manager reported that following his meeting with CG Historical Society members the lease agreement has been executed by the Historical Society and is ready for execution by the Township. Mr. Tucci noted the resolution on the agenda to authorize signature by the Township. The Manager also noted a resolution on the agenda to authorize execution of an agreement with Passaic Valley Sewer Commission for treatment and disposal of municipal sludge. Mr. Tucci recused himself from any further discussion of the agreement or resolution. The Manager noted a memo from the Police Chief pertaining to a request from a local business owner on Lewis Rd. for modification of parking restrictions on Lewis Rd. Following discussion, there was consensus that the Township Attorney draft the necessary ordinance to modify the parking restrictions as recommended by the Traffic Safety Officer. The Manager noted a memo from the Police Chief that suggested review and potential amendment of the single-family rental ordinance to address short/prohibit short term rental, specifically air BNB, to which the governing body agreed. The Manager announced the upcoming volunteer Fire Dept. annual Shred-It fundraiser event on October 17th. Mr. Tucci also noted correspondence from Ridgewood Acres Neighborhood Assoc. advising cancellation of the annual garage sale and block party as a result of COVID pandemic. The manager also noted the passing of former Township Attorney Scrivo's father. Mr. Tucci introduced his new administrative secretary Sukaina Barlas.
- b) Township Clerk The Clerk reported receipt of three letters of interest for the current Zoning Board vacancy. The Clerk also advised that two candidates filed for the current Council vacancy, and will appear on the ballot of the general election. Ms. Stutz provided an updated on the conduct of the election and addressed questions from the governing body. Ms. Stutz advised that the Township is awaiting confirmation of location of a secure ballot drop box within the Township and polling sites. Councilman Maceri again objected to the conduct of the election as a vote by mail election.
- c) Township Attorney Attorney Semeraro noted a memo from the Township's tax appeal counsel requesting authorization for settlement of a tax appeal for Block 180, Lot 46.01, to which the governing body agreed. The Township Attorney recommended that the resolution on the agenda (Item #10(a)) be tabled for revision, to which the governing body agreed.

d) Other Reports

Councilman Maceri acknowledged the efforts of David Schoner, Board of Education and high school students for the 9/11 commemorative flag display and ceremony.

Councilman Cicala also commended David Schoner and the CG Waves display and its incorporation into curriculum. Councilman Cicala requested an update on status of field construction at LRP school property. Councilman Cicala noted that there is quite a bit of foot traffic near the proposed field site between the board of education property and Panther Park that could pose some safety concerns. The Manager advised that safety fencing is required at the site. The Manager advised that final plans have been received and the developer (K. Hovnanian) has received bids. Mr. Tucci stated that construction is anticipated to commence in October.

Councilman Zichelli echoed previous comments on the CG Waves display. Councilman Zichelli also commented that the follow-up recognition of David Schoner, and the CG Waves flag display by the Port Authority Chairman Kevin O'Toole and Port Authority Police Dept. was well-deserved by Mr. Schoner. Councilman Zichelli announced the dates of the Historical Society annual pumpkin and apple sale at Morgan's Farm (10/3,4, 10 & 11). Councilman Zichelli noted that he received complaints regarding debris on Grove Ave. Councilman Zichelli requested an executive session to discuss a personnel matter.

Deputy Mayor Tanella requested an update on the status of Hilltop development. The Manager advised that as of last week 275 CO's have been issued and just over 400 units have been sold. Mr. Tucci commented that the project is ahead of schedule and attributed the high volume of sales to the COVID pandemic and current moving trend of people in urban areas to suburban areas. Deputy Mayor Tanella inquired the status of upgrades to the recycling center. The Manager advised that center is scheduled to be paved as part of the municipal road overlay program and additional signage will be placed to facilitate improvements. Deputy Mayor Tanella also inquired the status of the Route 23 (Pompton Ave.) road reconstruction project by the State. The Manager advised that the project is approximately 97% complete, that there a few road striping issues at certain intersections to be completed. The Manager further noted that the Township's traffic safety officer is to inspect intersections prior to completion. Mr. Tucci also noted that the Rt. 23 road project also included back-up battery traffic signals and accommodations for individual gas-powered back-up generators to operate the traffic signals during power outage and eliminates the need for traffic officers in those circumstances. Councilman Maceri noted a local business owner's concern regarding striping. The Manager confirmed that the State had the authority for striping as it is a State roadway.

Mayor Peterson reiterated previous positive comments regarding the 9/11 CG Waves display and ceremony. Mayor Peterson also thanked Port Authority Chairman O'Toole for recognition of David Schoner and the annual CG Waves display. The Manager commended Mayor Peterson for initiating the 9/11 blue light campaign. Mayor Peterson inquired the timeframe for re-opening public meetings to physical in-person participation. The Township Manager advised that certain building preparations are in progress to facilitate in-person public meeting participation as of the October 5 regular public meeting. Mr. Tucci described several protocols; temperature check upon entering building, wearing a mask and social distancing within meeting room. Mayor Peterson noted a Rt. 23 road striping concern; left turn signage on Rt. 23 south before Myrtle Ave. traffic signal and no corresponding road/driveway access.

8. NEW BUSINESS

a) To consider introduction of Pending Ordinance #20-864 – Ordinance Creating Deed Restriction on Property Owned by Township

The clerk read the Ordinance by title only:

AN ORDINANCE OF THE TOWNSHIP OF CEDAR GROVE, COUNTY OF ESSEX, STATE OF NEW JERSEY CREATING A DEED RESTRICTION ON PROPERTY OWNED BY THE TOWNSHIP OF CEDAR GROVE KNOWN AS BLOCK 250, LOTS 37, 81, 101, AND 141 TO DEDICATE SAID PARCELS FOR RECREATION AND CONSERVATION USES

WHEREAS, the real property known as Block 250, Lots 37, 81, 101, and 141 in the Township of Cedar Grove (the "Property"), which is part of a water shed property that is adjacent to a reservoir

that is a source of public water supply, and, with the exception of a few existing structures that are directly related to the operation of the reservoir, contains a large acreage of open space; and

WHEREAS, the Property was identified in the Open Space and Recreation Plan Element of the Township's Master Plan, adopted April 17, 2001, as a large tract of land that could be acquired to fill current and future open space demands; and

WHEREAS, consistent with the Open Space and Recreation Plan Element, the Township Council deemed the Property to be important to preserve as open space, and, as authorized by Ordinance No. 19-845, the Township of Cedar Grove purchased and is now the owner of the Property; and

WHEREAS, the Township Council now wishes to effectuate the Property's preservation by authorizing a deed restriction on the Property so that the Property will only be used for passive recreation and conservation purposes, including, but not limited to, watershed protection, parks, open space, passive recreation, or similar uses for either public outdoor recreation or conservation of natural resources, or both; and

WHEREAS, this restriction shall benefit the residents of the Township of Cedar Grove and the State of New Jersey by permanently protecting a vital source of public drinking water and preserving land for passive recreation and conservation purposes.

BE IT ORDAINED by the Township Council of the Township of Cedar Grove, County of Essex, State of New Jersey as follows:

SECTION 1:

The Township Council does hereby authorize the restriction of Block 250, Lots 37, 81, 101, and 141 to in the future be utilized only for passive recreation and conservation purposes and same shall be perfected by way of recording a deed restriction from the Township to the Township.

SECTION 2:

The Mayor and the Township Clerk are authorized to execute such Deed Restriction and any other documents necessary to effectuate this transaction.

SECTION 3:

The Township Clerk shall publish this Ordinance in accordance with law.

SECTION 4:

Any ordinances or parts thereof in conflict with the provisions of this Ordinance are hereby repealed as to their inconsistencies only.

SECTION 5:

Each section of this ordinance is an independent section, and the holding of any section or part thereof to be unconstitutional, void or ineffective for any cause shall not be deemed to affect the validity or constitutionality of any other sections or parts thereof.

SECTION 6:

This Ordinance shall take effect immediately upon final passage and publication as provided by law.

Deputy Mayor Tanella moved that Pending Ordinance #20-864 be passed at first reading, published in the Verona-Cedar Grove Times as a pending ordinance with a public hearing of October 5, 2020, seconded by Councilman Zichelli, and passed by the following vote:

WHEREAS, The Annual Report of Audit for the year 2019 has been filed by a Registered Municipal Accountant with the Municipal Clerk as per the requirements of N.J.S.A.40A:5-6, and a copy has been received by each member of the governing body, and

WHEREAS, the Local Finance Board of the State of New Jersey is authorized to prescribe reports pertaining to the local fiscal affairs, as per R.S. 52:27BB-34, and

WHEREAS, the Local Finance Board has promulgated <u>N.J.A.C.</u> 5:30-6.5, a regulation requiring that the governing body of each municipality shall, by resolution certify to the Local Finance Board of the State of New Jersey that all members of the governing body have reviewed, as a minimum, the sections of the annual audit entitled "Comments and Recommendations"; and

WHEREAS, the members of the governing body have personally reviewed as a minimum the Annual Report of Audit, and specifically the sections of the Annual Audit entitled "Comments and Recommendations", as evidenced by the group affidavit form of the governing body attached hereto; and

WHEREAS, such resolution of certification shall be adopted by the governing body no later than forty-five days after the receipt of the annual audit, pursuant to N.J.A.C. 5:30-6.5; and

WHEREAS, all members of the governing body have received and have familiarized themselves with, at least, the minimum requirements of the Local Finance Board of the State of New Jersey, as stated aforesaid and have subscribed to the affidavit, as provided by the Local Finance Board, and

WHEREAS, failure to comply with the promulgations of the Local Finance Board of the State of New Jersey may subject the members of the local governing body to the penalty provisions of <u>R.S.</u> 52:27BB-52, to wit:

R.S. 52-27BB-52 – "A local officer or member of a local governing body who, after a date fixed for compliance, fails or refuses to obey an order of the director (Director of Local Government Services), under the provisions of this Article, shall be guilty of a misdemeanor and, upon conviction, may be fined not more than one thousand dollars (\$1,000.00) or imprisoned for not more than one year, or both, in addition shall forfeit his office."
