MINUTES

SEPTEMBER 28, 2020

1. ROLL CALL – OPEN PUBLIC MEETING STATEMENT BY MAYOR

Mayor Peterson called the meeting to order at 7:10 p.m. and made the required announcement concerning the Open Public Meetings Act as follows: Adequate notice of this meeting was duly provided to the Verona-Cedar Grove Times and the Star Ledger, updated September 23, 2020, filed with the Township Clerk, and posted on the public bulletin board in the Municipal Building's lobby in accordance with the Open Public Meetings Act.

- 3. TOWNSHIP MANAGER The Township Manager provided the Finance Director's recommendation to decline request for waiver of a water/sewer bill penalty, to which the governing body agreed. The Manager announced the upcoming annual Breast Cancer Awareness Walk to be conducted October 22nd from 6:00-8:00 p.m. at Panther Park. The Manager also explained protocols that will be in place to permit public to attend public meetings commencing with the next Council meeting on 10/5; temperature/face recognition scan in lobby, masks required, social distance seating, that adhere to the Township's risk insurance fund COVID protocols. The Manager also noted that the high school is contemplating participating in a joint project with the PSC to create an environmental rain garden on the high school property.
- **4. TOWNSHIP ATTORNEY** Attorney Semeraro provided requested draft resolutions for placement on the next meeting agenda, to which the governing body agreed. Attorney Semeraro advised that the Rt. 23 parking ordinance amendment will be ready for the 10/5 meeting agenda.
- 5. TOWNSHIP CLERK The Clerk noted letter of interest received for existing Zoning Board vacancy. Following a brief discussion, there was consensus to schedule interviews for executive session on 10/19 at 6:30 p.m. The Clerk also noted recommendations from the CGHS Athletic Director of potential student members for Recreation Advisory Board. Following discussion, there was consensus to schedule interviews with recommended juniors for executive session 10/5 at 6:30. The Clerk provided an update on the upcoming November 3d general election and noted that election information has bee posted o the Township's website with links to County Clerk's website and the State's 2020 voter information portal. The Clerk also advised that the annual League of Municipalities Conference is a virtual conference.

6. COUNCIL REPORTS

Councilman Maceri commented that October is Domestic Violence Awareness Month. The governing body concurred with Councilman Maceri's suggestion to place a proclamation on the 10/5 agenda. Councilman Maceri noted continual littering at Panther Park despite daily maintenance.

Councilman Zichelli provided the dates and times of the Historical Society's annual pumpkin and apple sale at Morgan's Farm. Councilman Zichelli advised that O'Toole-Scrivo law firm purchased masks for distribution to Cedar Grove students. Councilman Zichelli suggested that the Board of Education be invited to the 10/5 Council meeting for presentation of the masks. Councilman Zichelli also suggested a "drive through" trick or teat event at Town Hall on Halloween, to which the governing body agreed.

Deputy Mayor Tanella requested an update on COVID status. The Manager advised that Township positive cases are stable. Deputy Mayor Tanella also requested the status for LRP field construction. The Manager advised that construction should commence mid-October. Deputy Mayor Tanella also inquired the status of South End Fire House. The Manager advised that the building is complete ready to schedule a ribbon cutting ceremony. Deputy Mayor Tanella requested an executive session to discuss a personnel matter.

The Manager addressed Mayor Peterson's inquiry regarding resumption of Township board/committee meetings, i.e. with social distance protocols in place. Mayor Peterson noted notification of an "unsafe" Township tree near 103 Westland Rd. The Manager advised the location will be inspected by DPW.
