**NOVEMBER 16, 2020** 

## 1. ROLL CALL – OPEN PUBLIC MEETING STATEMENT BY MAYOR

Mayor Peterson called the meeting to order at 7:10 p.m. and made the required announcement concerning the Open Public Meetings Act as follows: Adequate notice of this meeting was duly provided to the Verona-Cedar Grove Times and the Star Ledger, filed with the Township Clerk, and posted on the public bulletin board in the Municipal Building's lobby in accordance with the Open Public Meetings Act.

## 2. APPROVAL OF MINUTES

**3. TOWNSHIP MANAGER** – The Township Manager requested authorization for preparation of a bond ordinance for acquisition of Police Department communications system, to which the governing body agreed. The Manager noted receipt of draft agreement between the Township and Cedar Grove Ambulance & Rescue Squad to be executed prior to resuming services.

- **4. TOWNSHIP ATTORNEY** Attorney Semeraro confirmed the Municipal Engineer's recommendations for award of bid for snow removal and reconstruction of Ozone Ave. following bid reviews. Attorney Semeraro requested an executive session to discuss potential litigation regarding the Township's solicitation ordinance.
- **5. TOWNSHIP CLERK** The Clerk reported that the County Clerk is expected to certify the results of the November 3<sup>rd</sup> general election on November 23<sup>rd</sup>. The Clerk advised that the results of the municipal election for council vacancy can then be certified.

## 6. COUNCIL REPORTS

Councilman Maceri congratulated Councilman Zichelli on the outcome of recent election for council vacancy.

Councilman Cicala congratulated the CGHS boys' soccer team on their first ever State game win, and advance to quarter finals.

Councilman Zichelli reported receipt of check from Essex County Open Space Fund for barrier-free playground equipment at Community Park.

Deputy Mayor Tanella suggested that the Clerk ascertain interest of expiring board/committee members in re-appointment, to which the governing body agreed. Deputy Mayor Tanella also suggested advertising for board/committee interest. Deputy Mayor Tanella requested an executive session to discuss RFP for professional services.

Mayor Peterson noted receipt of a noise complaint by a landscaper. The Manager commented that the township is governed by the State's noise ordinance that establishes permitted decibel levels at specific times. The Manager recommended investigation of the complaint by the Police Dept. Mayor Peterson suggested a white light initiative to celebrate the holiday season. The Manager advised the annual tree lighting event may be virtual because of new outdoor gathering restrictions/limits. The Manager suggested a drive by holiday event hosted by the Recreation Dept. in lieu of the usual event, to which the governing body agreed.

a) To consider introduction of Pending Ord. #20-867 – 2021 Allowable Rent Increase

The clerk read the Ordinance by title only:

AN ORDINANCE SETTING THE MAXIMUM ALLOWABLE RENT INCREASE PURSUANT TO CHAPTER 208 OF THE CODE OF THE TOWNSHIP OF CEDAR GROVE

BE IT ORDAINED by the Township Council of the Township of Cedar Grove that the maximum allowable rent increase in the Township for the year 2021 pursuant to Chapter 208 of the Code of the Township of Cedar Grove is hereby set at 2.2%.

This Ordinance shall take effect upon final reading, adoption, and publication in accordance with the law.

Councilman Cicala moved that Pending Ordinance #20-867 be passed at first reading, published in the Verona-Cedar Grove Times as a pending ordinance with a public hearing of December 7, 2020, seconded by Deputy Mayor Tanella, and passed by the following vote:
