PUBLIC MEETING MINUTES DECEMBER 6, 2021

1. ROLL CALL, INVOCATION AND FLAG SALUTE

Mayor Tanella called the meeting to order at 7:00 p.m.

The clerk read the Ordinance by title only:

PENDING ORDINANCE #21-884

AN ORDINANCE OF THE TOWNSHIP OF CEDAR GROVE, COUNTY OF ESSEX, NEW JERSEY APPROVING THE PAYMENT IN LIEU OF TAXES APPLICATION AND AUTHORIZING THE EXECUTION OF A FINANCIAL AGREEMENT PURSUANT TO N.J.S.A. 40A:20-1 ET SEQ. BY AND BETWEEN THE TOWNSHIP OF CEDAR GROVE AND 36 CLIFFSIDE DRIVE URBAN RENEWAL, LLC FOR PROPERTY LOCATED ON LOTS 247, 320, 330, 551.1 AND 552 IN BLOCK 280, AS SHOWN ON THE OFFICIAL TAX MAP OF THE TOWNSHIP OF CEDAR GROVE AND LOCATED IN THE 36 CLIFFSIDE DRIVE REDEVELOPMENT AREA REDEVELOPMENT PLAN

WHEREAS, on December 6, 2021, the Township Council of the Township of Cedar Grove, in the County of Essex (the "Township"), a public body corporate and politic of the State of New Jersey (the "State") adopted an ordinance approving and adopting the Cliffside Drive Redevelopment Area Redevelopment Plan (the "Redevelopment Plan") in accordance with the Local Redevelopment and Housing Law, <u>N.J.S.A.</u> 40A:12A-1 et seq. (the "Redevelopment Law"); and

WHEREAS, the Redevelopment Plan relates to five properties within the Township (collectively the "Redevelopment Area"); and

WHEREAS, real property located within the Redevelopment Area, which is designated on the Official Tax Map of the Township as Block 280, Lots 247, 320, 330, 551.1 and 552 (the "Project Area"), is presently owned or controlled by 36 Cliffside Drive, LLC, which is in the process of transferring ownership and control to 36 Cliffside Drive Urban Renewal, LLC, an urban renewal entity to be formed to own the Project Area (collectively the "Redeveloper"); and

WHEREAS, the Redeveloper shall construct upon the Project Area 347 residential units (including 57 affordable housing units) and amenity and recreation space as depicted on the project site plan (the "Project"); and

WHEREAS, on September 15, 2020, the Redeveloper obtained Preliminary and Final Major Site Plan approval from the Township Planning Board for the construction of the Project; and

- **WHEREAS,** pursuant to and in accordance with the provisions of the Long-Term Tax Exemption Law, N.J.S.A. 40A:20-1 et seq. (the "Tax Exemption Law"), the Township is authorized to provide for a Payment in Lieu of Taxes ("PILOT"), or tax abatement, within a redevelopment area; and
- **WHEREAS,** the Redeveloper has submitted an application to the Township for the approval of the Project, as such term is defined herein, as an urban renewal project, as such term is used in the Tax Exemption Law, all in accordance with N.J.S.A. 40A:20-8 (the "PILOT Application"); and
- **WHEREAS,** the Redeveloper shall cause to create and obtain approval as an urban renewal entity pursuant to the Tax Exemption Law for the purposes of acquiring, owning, holding, developing, maintaining, financing, mortgaging, improving, operating, leasing, managing, using, refinancing, selling, subdividing, or otherwise dealing with the Project Area and the Project; and
- **WHEREAS,** the PILOT Application requested a 30-year term for a financial agreement and an annual service charge based on annual gross revenues from the Project as set forth in the Financial Agreement; and
- **WHEREAS,** the Township Council deems it to be in the best interest of the Township to pass an Ordinance authorizing the Township to enter into the proposed Financial Agreement with 36 CLIFFSIDE DRIVE URBAN RENEWAL, LLC on the terms and conditions stated in the applicable form of Financial Agreement attached to this Ordinance.
- **NOW THEREFORE, BE IT ORDAINED AND ENACTED** by the Township Council of the Township of Cedar Grove, County of Essex, New Jersey, as follows:
- **Section 1.** In accordance with the Tax Exemption Law, including without limitation N.J.S.A. 4A:20-11, the Township hereby finds and determines that this Financial Agreement is to the direct benefit of the health, welfare and financial well-being of the Township and its citizens because it allows for the development of a vacant and fallow site into a productive, useful and job-creating property.
- (a) The costs associated with the tax exemption granted herein are minor compared to the <u>estimated</u> Total Project Cost in excess of Sixty Million dollars and the benefit created by the construction and/or renovation of the Improvements, the employment of approximately 200 skilled construction workers during the construction period, and the creation of approximately two to four opportunities for permanent employment;
- (b) Without the tax exemption granted herein it is highly unlikely that the Project would otherwise be undertaken. The grant of the long term tax exemption will permit Redeveloper to repurpose a fallow site into a productive, useful and affordable housing creating property; and
- (c) Exemption from taxation of the Project Area, subject to the Financial Agreement and receipt by the Township of an annual service charge in lieu of taxes as set forth in the Financial Agreement, allows maximum redevelopment of the Project Area and is, therefore, in the best interest of the Township and in accordance with the Tax Exemption Law and the public purposes pursuant to which the redevelopment has and shall be undertaken.
- **Section 2.** The PILOT Application is hereby approved and accepted by the Mayor and Township Council, modified as set forth in the Financial Agreement.

DECEMBER 6, 2021

Section 3. The Financial Agreement is hereby authorized to be executed and delivered on behalf of the Township by the Mayor in substantially the form annexed hereby as <u>Exhibit A</u>. Township Counsel is authorized to prepare and the Mayor is hereby authorized to execute any additional documents that may be necessary to implement and carry out the intent of the within Ordinance and the form Financial Agreement. The Township Clerk is hereby authorized and directed to attest to the execution of the Financial Agreement by the Mayor and to affix the corporate seal of the Township to the Financial Agreement.

Section 4. This Ordinance shall take effect upon final passage and publication as required by law.
