### 6. CONSENT AGENDA

a) To consider resolution concerning 2022 Cash Management Plan

The following resolution had been posted on the bulletin board, and a brief synopsis was given by the Township Clerk:

# CASH MANAGEMENT PLAN

**BE IT RESOLVED** by the Township Council of the Township of Cedar Grove, County of Essex, that for the year 2022, the following shall serve as the cash management plan of the Township of Cedar Grove.

1. Cash Management and Investment Objectives

The Township of Cedar Grove objectives in this area are:

- A. Preservation of capital.
- B. Adequate safekeeping of assets.

C. Maintenance of liquidity to meet operating needs.

D. Diversification of the Township's portfolio to minimize risks associated with individual investments.

E. Investment of assets in accordance with State and Federal Laws and regulations.

## 2. <u>Designation of Official Depositories</u>

2. Designated official depositories are required to submit to the Chief Financial Officer, a copy of the Governmental Unit Deposit Protection Act Notification of eligibility, which is filed semiannually with the Department of Banking each June 30th and December 31st of each year.

## 3. <u>CASH MANAGEMENT</u>

1. All funds shall be deposited within 48 hours of receipt in accordance with N.J.S.A. 40A:5-15.

2. The Chief Financial Officer shall minimize the possibility of idle cash accumulating in accounts by assuring that the amounts in excess of negotiated compensating balances are kept in interest bearing accounts or promptly swept into the investment portfolio.

3. The method of calculating banking fees and compensating balances shall be reviewed on a monthly basis.

4. Investment decisions shall be guided by the cash flow projections prepared by the Chief Financial Officer.

## 4. <u>PERMISSIBLE INVESTMENTS</u>

1. Bonds or other obligations of the United States of America or obligations guaranteed the United States of America.

2. Government money market mutual funds.

3. Any federal agency or instrumentality obligation authorized by Congress that matures within 397 days from the date of purchase, and has a fixed rate of interest not dependent on any index or external factors.

4. Bonds or other obligations of the local unit or school districts of which the local unit is a part.

5. Any other obligations with maturities not exceeding 397 days, as permitted by the Division of Investments.

- 6. Local Government investment pools.
- 7. New Jersey Cash Management Fund
- 8. Repurchase agreements of fully collateralized securities.

## 5. <u>AUTHORITY FOR INVESTMENT MANAGEMENT</u>

1. The Chief Financial Officer is authorized and directed to make investments on behalf of the Township. All investment decisions shall be consistent with this plan and all appropriate regulatory constraints.

### 6. <u>SAFEKEEPING</u>

1. Securities purchased on behalf of the Township shall be delivered electronically or physically to the Township's custodial bank, which shall maintain custodial and/or safekeeping accounts for such securities on behalf of the Township.

## 7. <u>AUDIT</u>

1. The Cash Management Plan shall be subject to annual audit conducted pursuant to N.J.S.A. 40A:5-14.

c) To consider resolution concerning interest on delinquent taxes

The following resolution had been posted on the bulletin board, and a brief synopsis was given by the Township Clerk:

**WHEREAS**, N.J.S.A. 54:4-67 regulates the due dates for the payment of taxes and authorizes the rate of interest for delinquent payment of taxes, and authorizes a grace period not exceeding ten (10) days;

**NOW, THEREFORE, BE IT RESOLVED**, by the Township Council of the Township of Cedar Grove, that the Tax Collector is hereby authorized to allow a period of ten (10) days grace from the quarterly tax due date before charging interest; and

**BE IT FURTHER RESOLVED** that the rate of interest to be charged for the payment of taxes, assessments, and property maintenance when they become delinquent shall be at the rate of eight percent (8%) per annum on the first \$1,500.00 of the delinquency, eighteen percent (18%) per annum of any amount in excess of \$1,500.00, and an additional six percent (6%) penalty for a delinquency over \$10,000.00 if not paid prior to the end of the calendar year.

BE IT FURTHER RESOLVED that this resolution will take effect January 1, 2022.

d) To consider resolution concerning 2022 tax sale certificate redemption fee

WHEREAS, in accordance with N.J.S.A. 54:5-54 provides that the Tax Collector shall provide to any party entitled to redeem a Tax Sale Certificate two calculations of the amount required for redemption

within a calendar year at no cost. For each subsequent calculation requested from the Tax Collector there shall be a fee of \$50.00; and

**WHEREAS,** in accordance with N.J.S.A. 54:5-97.1 provides that the Tax Collector shall charge a lienholder of a Tax Sale Certificate a fee of \$50.00 for the calculation of the amount due to redeem the Tax Sale Certificate.

**NOW, THEREFORE, BE IT RESOLVED**, by the Township Council of the Township of Cedar Grove, that the Tax Collector is hereby authorized to provide to any party entitled to redeem a Tax Sale Certificate two calculations of the amount required for redemption within a calendar year at no cost. For each subsequent calculation requested from the Tax Collector there shall be a fee of \$50.00. The Tax Collector is hereby authorized to charge a lienholder of a Tax Sale Certificate a fee of \$50.00 for the calculation of the amount due to redeem the Tax Sale Certificate

### 7. NEW BUSINESS

a) To consider introduction of Pending Ordinance #22-885 – Establishing Verona-Cedar Grove Flood Control Board

The clerk read the Ordinance by title only:

### Pending Ordinance No. 22-885

AN ORDINANCE FORMING AND ESTABLISHING THE VERONA-CEDAR GROVE FLOOD CONTROL BOARD.

BE IT ORDAINED by the Township Council of the Township of Cedar Grove, as follows:

### Section 1

WHEREAS, the Township of Cedar Grove finds and declares that it is in its interest to protect and relieve its residents and the occupants of property within the Township of Cedar Grove from the adverse effects of uncontrolled storm water drainage and the conditions of flooding; as authorized by <u>N.J.S.A.</u> 40A:27-2, as the township has experienced on-going and sever damage from Hurricane Ida and other storms in the past decade; WHEREAS, the Mayor and Council of the Township of Cedar Grove have taken cognizance of all existing and proposed upstream and downstream developments which may affect, or be affected by, the proposed flood control facility in accordance with <u>N.J.S.A.</u> 40A:27-4;

WHEREAS, before undertaking the construction of any flood control facility, the Mayor and Council are cognizant that notice must be given, by certified mail, to all upstream and downstream municipalities, soil conservation districts and counties, and the Department of Environmental Protection, of any intent to construct one or more flood control facilities pursuant to <u>N.J.S.A.</u> 40A:27-4;

WHEREAS, prior to the construction of any flood control facility, the Township of Cedar Grove recognizes that the Verona-Cedar Grove Flood Control Board must request information from all upstream governmental entities, indicating which proposed developments might alter the flow of water at any proposed flood control facility;

NOW, THEREFORE, BE IT ORDAINED, by the Mayor and Council of the Township of Cedar Grove that, pursuant to the Municipal & County Flood Control Act, <u>N.J.S.A.</u> 40A:27-1, <u>et seq</u>., the Township hereby amends and supplements the Ordinances of the Township of Cedar Grove to include the following new Article entitled "Ordinance to Form and Establish the Verona-Cedar Grove Flood Control Board" (hereinafter, the "Board"):

1. The Mayor and Council conclude that the public health, safety and welfare can best be assured by the establishment of the Board, and its review of the potential acquisition, construction, financing, improvement, maintenance and operation of flood control facilities in cooperation with other local units, as set forth in <u>N.J.S.A.</u> 40A:27-4;

2. The Mayor and Council find that the Board will contribute to the overall management of the surface water of the Passaic River and the Peckman River basins, insofar as those basins impact upon the properties located within the Township;

3. Once the Board is appointed pursuant to the other provisions of this Ordinance, the Board shall make, or cause to be made any necessary surveys, investigations, studies, borings, maps, plans, drawings and estimates of costs and revenues relating to the provision of flood control facilities, provided, however, the Board (or the Township of Cedar Grove on behalf of the Board) first secures or approves the full funding by way of grants for such surveys, investigations and the like;

4. Upon the adoption of such necessary ordinances or resolutions of the Township of Verona, upon passage in advance of a resolution adopted by the Mayor and Council of the Township of Cedar Grove and subject to the approval of the Township of Cedar Grove's Municipal Attorney as to the form of such contracts, the Township of Cedar Grove or the Board, as the case may be, as contractor, shall enter into a contract with the contracting local units of the Township of Verona, to construct, maintain, improve, acquire, or finance a flood control facility for the use of the two municipalities.

5. In order to effectuate the establishment of the Board, the Township of Cedar Grove authorizes, upon the adoption of requisite like ordinances by the contracting local units of the Township of Verona, the creation of the Board, as set forth below.

6. The "Verona-Cedar Grove Flood Control Board" shall consist of members from the Township of Verona and the Township of Cedar Grove. Each of the members shall be appointed by the governing body for a term of three (3) years, except that upon the creation of the Board, the first, second and third appointed member of each of the member local units will be appointed for three, two, and one year terms, respectively, to effectuate a system of staggered terms. The Chair of the Board shall be elected by the members of the Board each year; however, a member from each of the member local units may serve as Chair only every other year.

7. The "Verona-Cedar Grove Flood Control Board" shall jointly purchase, construct, improve, extend, enlarge or reconstruct flood control facilities on behalf of its member local units subject to the approval of the Council or Governing Body of each of the member local units.

8. The "Verona-Cedar Grove Flood Control Board" shall jointly receive and accept, on behalf of its member local units, from the federal or State government or any agency thereof, grants for the planning, acquisition, purchase, construction, extension, enlargement, reconstruction, improvement or financing of any of these facilities and to receive and accept contributions from any source of either money, property, labor or other things of value to be held, used and applied for the purposes for which these grants and contributions may be made subject to the approval of the Council or Governing Body of each of the member local units.

9. Any budgetary funding provided by the Township of Cedar Grove for the operation of the "Verona-Cedar Grove Flood Control Board" shall be subject to the annual availability and appropriation of sufficient funds.

10. The creation of the Verona-Cedar Grove Flood Control Board shall be subject to and contingent upon each of the member local units satisfying all of the terms and conditions precedent contained in this ordinance. The within Ordinance is only an enabling Ordinance subject to all of the various statutes and contingencies mentioned herein and shall only become fully operative once an interlocal contract is executed among the municipalities and this regional flood board is compliant with the Interlocal Act the Municipal Services Act, "Pay-to-Play Statute," Acquisition and Construction of Public Improvement Act and other such similar Acts.

11. None of the municipalities herein shall be required, by virtue of this Ordinance, to expend any funds by virtue of this ordinance. It is contemplated by this Ordinance that this is a joint undertaking amongst two (2) municipalities to be separately funded by future grants and other such similar aid and funding as may be hereinafter designated, by separate enactments.

12. This Ordinance being vital to the public health, safety and welfare shall take effect immediately upon final passage and as provided by law.

- 13. As used in this Ordinance:
  - (a) "Contracting local unit" means a municipality which enters into a contract with another municipality for the construction, maintenance, improvement, acquisition, or financing of a flood control facility for its own use;
  - (b) "Contractor" means a local unit, which enters into a contract with a contracting local unit to construct, maintain, improve, acquire or finance flood control facilities for the contracting local unit.

- (c) "Cost" as applied to flood control facilities or extensions or additions thereto, means the cost of construction, reconstruction or maintenance, improvement, the cost of all labor, materials, machinery and equipment, the costs of all lands, property, rights and easements acquired, financing charges, interest on bonds issued to finance a facility prior to, during and after acquisition or construction, the cost of plans and specifications, surveys or estimates of costs and of revenues, the cost of engineering and legal services, and all other expenses necessary or incident to determining the feasibility or practicability of the construction, reconstruction, improvement or maintenance of a facility, administrative expenses and such other expenses as may be necessary or incident to the construction, maintenance or acquisition of a facility, and the financing herein authorized. Any obligation or expense incurred by a local unit in connection with any of the foregoing items of cost prior to the issuance of bonds or notes as authorized herein may be reimbursed to the local unit out of the proceeds of bonds issued under the provisions of this chapter;
- (d) "Flood control facilities" means the dams, drainage ways, structures and other real and personal property acquired, constructed, operated, financed, maintained or improved or to be acquired, constructed, operated, financed, maintained or improved by a local unit for the purposes of flood control, including storage reservoirs, dikes, diversions, dams, spillways, levees, revetments, drains, ditches or channel improvements, such as widening, deepening, straightening, clearing, desnagging, sloping, building and filling in, and other plants, structures, boats, conveyances and other real or personal property and rights therein, and appurtenances necessary for the control of flooding, the preservation of stream flow and the management of surface water, including any storm sewers, storm drains, drainage facilities, and detention basins, and the dredging or desnagging of any drainage ways;
- (e) "Local unit" means a municipality or a county;
- (f) "Member local units" means the Township of Cedar Grove and the Township of Verona;
- (g) "Municipal & County Flood Control Act" means <u>N.J.S.A.</u> 40A:27-1, <u>et seq</u>.

#### Section 2

All Ordinances and parts of Ordinances inconsistent herewith are hereby repealed to the extent of such inconsistency.

#### Section 3

If any section, paragraph, subdivision or provision of the subsection shall be adjudged invalid, such adjudication shall apply only to the paragraph, subdivision clause or provision so adjudged and the remainder of the subsection shall be deemed valid and effective.

#### Section 4

This Ordinance shall take effect as prescribed by law.

b) To consider resolution concerning purchase of water meters through State contract

The following resolution had been posted on the bulletin board, and a brief synopsis was given by the Township Clerk:

**WHEREAS**, the Township of Cedar Grove utilizes the Morris County Cooperative Pricing Council Contract #47 for water meters, data recorders and radio frequency meter interface units; and

**WHEREAS**, the contract amount for water meters, data recorders and radio frequency meter interface units will not exceed \$90,000.03; and

**WHEREAS**, the funds are available to satisfy our obligations under this contract through Bond Ordinance No. 21-873.

**NOW THEREFORE BE IT RESOLVED** by the Township Council of the Township of Cedar Grove authorizes the Township of Cedar Grove to purchase from the Morris County Cooperative Pricing Council Contract #47 for water meters, data recorders and radio frequency meter interface units from RIO Supply Inc. for an amount not to exceed \$90,000.03.

**WHEREAS,** it is desirable from time to time to purchase firefighter protective clothing, equipment and accessories under contracts entered into on behalf of the State by the said Division without the necessity of advertising for bids, or in cases where no bids have been received; and

**WHEREAS,** it is desirable to purchase firefighter protective clothing, equipment and accessories under such contracts enter into on behalf of the State of New Jersey by said Division during the year 2022;

**WHEREAS,** funds for the purchase of the firefighter protective clothing, equipment and accessories are available in the Bond Ordinance #21-872.

**NOW, THEREFORE, BE IT RESOLVED**, by the Township Council of the Township of Cedar Grove, that the purchase of the firefighter protective clothing, equipment and accessories be awarded to New Jersey Fire Equipment Co., through State Contract No. T0790.
