**1. ROLL CALL, INVOCATION AND FLAG SALUTE**

Mayor Peterson called the meeting to order at 7:00 p.m.

Tree Service of Montclair, New Jersey for the loading, transportation and disposal of leaves in the amount of \$7.50 per cubic yard for a one-year contract term; and

**BE IT FURTHER RESOLVED** that the proper township officials be instructed to execute a contract on behalf of the Township.

## **6. MEETING OPEN TO RESIDENTS OF THE TOWNSHIP WISHING TO BE HEARD ON ANY ITEM ON THE AGENDA**

Mayor Peterson opened this portion of the meeting to anyone wishing to be heard on any item on the agenda. There being no one present wishing to be heard, Mayor Peterson closed this portion of the meeting.

## **7. REPORTS OF TOWNSHIP OFFICIALS**

- a) Township Manager – The Township Manager thanked the participants in the annual Clean Sweep Day conducted on Saturday, June 5<sup>th</sup>. The Manager noted a letter from a resident to donate a “Pride” flag. Mr. Tucci advised that the Township has already purchased the flag. The Manager noted a memo from the Police Chief concerning Cedar Grove Ambulance Squad service. Mr. Tucci noted two block party requests to which the governing body agreed. The Township Manager announced the retirement of Police Chief Joseph Cirasa. Mr. Tucci noted the Chief’s last day is June 25<sup>th</sup>, retirement is effective January 1, 2022. Mr. Tucci and all governing body members extended best wishes to Joseph Cirasa.

- b) Township Clerk – The Township Clerk advised that the Primary Election is Tuesday, June 8<sup>th</sup> and provided polling hours (6:00 a.m. – 8:00 p.m.).
- c) Township Attorney – Attorney Nabbi requested an executive session to discuss pending litigation.
- d) Other Reports

Councilman Maceri – Councilman Maceri thanked the Fire Dept. for hosting the Memorial Day ceremony. Councilman Maceri also acknowledged the recently conducted 30<sup>th</sup> annual Clean Sweep Day event. Councilman Maceri noted fundraising efforts of Cedar Grove UNICO that resulted in the recent award of three scholarships to local high school students. Councilman Maceri reported that the Environmental Commission held its first in-person meeting since the COVID pandemic.

Councilman Cicala – No report

Councilman Zichelli – Councilman Zichelli noted that 85% of eligible Cedar Grove population has been COVID vaccinated, the third highest in the State.

Deputy Mayor Tanella – No report

Mayor Peterson reported that she attended the recent Fire Dept. Family Day and thanked all Fire Department volunteers for their service. Mayor Peterson commented that the Public Library serves as cooling station in severe heat and confirmed notification of same is made through the Township's Nixle alert system, website and social media page. Mayor Peterson read a statement recognizing June as LGBTQ Pride month and intention to schedule a flag raising ceremony at a Township location, to which the governing body agreed.

## 8. NEW BUSINESS

- a) To consider introduction of Pending Ord. #21-875 - Amending Chapter 55 of the Township code entitled "Police Department"

The clerk read the Ordinance by title only:

### **AN ORDINANCE AMENDING CHAPTER 55 OF THE CODE OF THE TOWNSHIP OF CEDAR GROVE, ENTITLED "POLICE DEPARTMENT."**

**WHEREAS**, pursuant to N.J.S.A. 40A:14-118, the governing body of a municipality is empowered to create and establish, as an executive and enforcement function of municipal government, a police department; and

**WHEREAS**, ordinances regulating police departments are subject to modification due to changing needs of a municipality and to enhance the efficiency and effectiveness of the operations of a police department; and

**WHEREAS**, the Township Council of the Township of Cedar Grove deems it to be in the best interests of the Township of Cedar Grove and the Township of Cedar Grove Police Department to amend the current ordinances regulating the Township of Cedar Grove Police Department.

**NOW, THEREFORE, BE IT ORDAINED** by the Township Council of the Township of Cedar Grove, as follows:

The Code of the Township of Cedar Grove, Chapter 55 entitled, "POLICE DEPARTMENT," is hereby amended as follows:

**Section 1.**

Section 55-1(A)(1) is deleted in its entirety with the following provision replacing it:

(A)The Police Department of the Township heretofore established is hereby continued and shall consist of the following personnel:

(1) In order of rank, one Chief of Police, one Captain, four Lieutenants, five Sergeants and 20 police patrol officers. Such appointees, following a satisfactory probationary period as set forth in § 52-23 of the Code of the Township of Cedar Grove, shall then become regular and permanent members of the Police Department as provided in N.J.S.A. 40:47.5.

**Section 2.**

All ordinances of the Township of Cedar Grove which are inconsistent with the provisions of this Ordinance are hereby repealed as to the extent of such inconsistency.

**Section 3.**

Should any section, clause, sentence, phrase or provision of this Ordinance be declared unconstitutional or invalid by a Court of competent jurisdiction, such decision shall not affect the remaining portions of this Ordinance.

**Section 4.**

This Ordinance shall take effect upon final passage, adoption, and publication in the manner prescribed by law.

Deputy Mayor Tanella moved that Pending Ordinance #21-870 be passed at first reading, published in the Verona-Cedar Grove Times as a pending ordinance with a public hearing of June 21, 2021, seconded by Councilman Zichelli, and passed by the following vote:

BE IT ORDAINED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF CEDAR GROVE AS FOLLOWS:

Section 1. Unless heretofore created and established in the Township of Cedar Grove, the salary grades and ranges, wages and fees of all officers and employees of the Township of Cedar Grove shall be as follows:

Section 2. The Township Council shall, by Resolution, and in accordance with labor contracts, fix the salary of each officer and employee within the salary range as set forth in Section 1 of the Ordinance.

Section 3. This Ordinance shall take effect twenty (20) days after the first publication after passage pursuant to law. When adopted, the provisions of Section 1 shall be retroactive to January 1, 2021 and shall be deemed to have taken effect as of that date.

- c) To consider resolution concerning estimated tax bills

The following resolution had been posted on the bulletin board, and a brief synopsis was given by the Township Clerk:

**WHEREAS**, the Essex County Board of Taxation is unable to certify tax rates for the year 2021 in a timely manner; and

**WHEREAS**, without a 2021 certified tax rate the Tax Collector of the Township of Cedar Grove will be unable to issue 2021 tax bills on a timely basis; and

**NOW, THEREFORE, BE IT RESOLVED**, by the Township Council of the Township of Cedar Grove, as follows:

1. The Tax Collector of the Township of Cedar Grove is hereby authorized and directed to prepare and issue estimated tax bills for the Township of Cedar Grove for the third installment of 2021 taxes. The Tax Collector shall proceed and take such actions as are permitted and required by Chapter 72, Public Laws of 1994 and N.J.S.A. 54:4-66.2 and 54:4-66.3.
2. The total estimated tax levy for 2021 is \$56,386,387.80. The estimated tax rate for 2021 is \$2.537.

- d) To consider resolution concerning purchase of radio equipment & maintenance through New Jersey Cooperative Purchasing Alliance

**WHEREAS**, in accordance with N.J.S.A. 40A:11-11, the County of Bergen is the lead public agency for the #CK04 New Jersey Cooperative Purchasing Alliance which utilizes the combined purchasing power of 250 members; and

**WHEREAS**, the Township of Cedar Grove has availed itself to purchase radio equipment and maintenance entered into on behalf of the New Jersey Cooperative Purchasing Alliance pursuant to N.J.S.A. 40A:11-11; and

**WHEREAS**, it is desirable to purchase radio equipment and maintenance under the contracts entered into on behalf of New Jersey Cooperative Purchasing Alliance during 2021; and

**WHEREAS**, the funds for the purchase of the radio equipment and maintenance are available in the Bond Ordinance No. 20-868.

**NOW THEREFORE BE IT RESOLVED** by the Township Council of the Township of Cedar Grove authorizes the Township of Cedar Grove to utilize the New Jersey Cooperative Purchasing Alliance for the purchase of radio equipment and maintenance for the Cedar Grove Police Department from Northeast Communications Inc.

## **10. MEETING OPEN TO RESIDENTS OF THE TOWNSHIP WISHING TO BE HEARD ON ANY ITEM ON OR OFF THE AGENDA CONCERNING TOWNSHIP BUSINESS**

Mayor Peterson opened this portion of the meeting to anyone wishing to be heard.

Kate Hartwyk; Essex County Liaison – Ms. Hartwyk announced upcoming County sponsored fishing derby and location. Ms. Hartwyk also noted the paper shredding day for Essex County residents on June 19<sup>th</sup> from 9:00 a.m. – 1:00 p.m. at 99 W. Bradford Ave. Ms. Hartwyk reported that the County will resume its concert series during the month of August at various County parks, conduct 4<sup>th</sup> of July fireworks, and re-open the Robert O’Toole Community Center for the senior lunch program.

David Vissering; 27 Rose Terr. – Mr. Vissering requested installation of STOP signs at the intersections of Clara Pl./Ira Rd. and Rose Terr./Ira Rd. Mr. Vissering noted a line of sight concern at 6 Rose Terr. and expressed concern regarding permitted parking on Sweetwood Dr. near Pompton Ave. The Manager advised that Mr. Vissering’s traffic concerns will be directed to the Traffic Safety

Officer. Mr. Vissering inquired the notification process to residents regarding the reconstruction of Ozone Ave. project. Mr. Vissering criticized the governing body for alleged lack of response to anti-semetic incidents at South End School property and Temple Shalom. Mr. Vissering also objected to the governing body’s adoption of a resolution (10/5/2020) pertaining to the conduct of 2020 general election. Mr. Vissering submitted a resolution for governing body consideration to rescind the referenced resolution.

There being no one else present wishing to be heard, Mayor Peterson closed this portion of the meeting.

AUTHORIZATION TO GO INTO EXECUTIVE SESSION

WHEREAS, Section 8 of the Open Public Meetings' Act (N.J.S.A.10:4-12 (b) (1-9) permits the exclusion of the public from a Meeting of the Mayor and Council in certain circumstances; and

WHEREAS, the Mayor and Council of the Township of Cedar Grove are of the opinion that such circumstances exist.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Township of Cedar Grove, County of Essex, State of New Jersey that:

1. The public shall be excluded from discussion of any action on the Executive Session of the Meeting of the Mayor and Council of June 7, 2021.
2. The general nature of the subject matters to be discussed is pending litigation.
3. It is anticipated at this time that the above stated subject matter will be made public as soon thereafter as it is deemed in the public interest to do so.
4. This Resolution shall take effect immediately.
