PUBLIC MEETING MINUTES APRIL 2, 2018

8. **NEW BUSINESS**

a) To consider introduction of Pending Ordinance #18-824 Amending Chapter 205 of the Township Code entitled "Recreation Areas, Use Of"

The clerk read the Ordinance by title only:

ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER 205 OF THE CODE OF THE TOWNSHIP OF CEDAR GROVE ENTITLED "RECREATION AREAS, USE OF"

BE IT ORDAINED by the Township Council of the Township of Cedar Grove that the Municipal Code be amended as follows:

SECTION 1

§ 205-7. Restricted activities.

The following language shall be added to existing language:

Except in the municipal pools, no person in any Public Recreation Area shall swim, bathe or wade in any waters or waterways.

SECTION 2

The following language shall be added as:

§ 205-8. Restrictions on Pollution and Littering.

- **A.** No person in any Public Recreation Area shall throw, discharge or otherwise place or cause to be placed in the waters of any pond, lake, stream or other body of water in or adjacent to any Public Recreation Area or any tributary, stream, storm sewer or drain flowing into such waters, any substance, matter or thing, liquid or solid, which will result in the pollution of such waters.
- **B.** No person in any Public Recreation Area shall dump, deposit or leave any material or debris, whether organic or inorganic. No refuse or trash shall be placed in any waters contiguous to any Public Recreation Area, or left anywhere, but may be placed in the proper receptacles provided therefor. If receptacles are not so provided, all such rubbish or waster shall be carried away from the Public Recreation Area by the person responsible for its presence and disposed of legally elsewhere.

SECTION 3

Each section of this ordinance is an independent section, and the holding of any section or part thereof to be unconstitutional, void or ineffective for any cause shall not be deemed to affect the validity of constitutionality of any other sections or parts thereof.

SECTION 4

Any ordinances or parts thereof in conflict with the provisions of this Ordinance are hereby repealed as to their inconsistencies only.

SECTION 5

This Ordinance shall take effect immediately as provided by law.

b) To consider resolution concerning request for dog park at County-Owned Cedar Grove Park

The following resolution had been posted on the bulletin board, and a brief synopsis was given by the Township Clerk:

A RESOLUTION SUPPORTING THE DESIGN AND CONSTRUCTION OF A DOG PARK BY THE COUNTY OF ESSEX AT CEDAR GROVE PARK IN THE TOWNSHIP OF CEDAR GROVE

WHEREAS, the County of Essex currently owns and operates dog parks for the enjoyment of Essex County residents and their dogs; and

WHEREAS, these dog parks are located in Brookdale Park in the Township of Montclair, South Mountain Reservation in the Township of Millburn, and in the Hilltop Reservation in the Borough of North Caldwell; and

WHEREAS, there is a desire on the part of Cedar Grove residents for an additional dog park; and

WHEREAS, the County of Essex owns Cedar Grove Park located on Fairview Avenue in the Township of Cedar Grove; and

WHEREAS, The Township of Cedar Grove Mayor and Council support the creation of a dog park at the Cedar Grove Park; and

WHEREAS, the park will provide a safe environment for residents and their family members. This park will not only enhance the beautiful park, but also the Robert O'Toole Community Center where family and friends are all welcome; and

WHEREAS, the Governing Body of the Township of Cedar Grove requests that the County of Essex design and construct a dog park at the County owned Cedar Grove Park.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Township of Cedar Grove, County of Essex, State of New Jersey as follows:

- 1. The Governing Body believes there is a desire among Cedar Grove and West Essex residents for an additional dog park in the West Essex area.
- 2. The Governing Body supports the County of Essex in designing and constructing a dog park on a section of Cedar Grove Park, in the Township of Cedar Grove.
- 3. The Mayor, and all other officials of the Township of Cedar Grove, are hereby directed

and authorized to take any and all necessary and appropriate actions, to carry out the subject and intent of this Resolution.

4. A copy of this resolution shall be forwarded to the appropriate officials at the County of Essex.
