MINUTES

DECEMBER 3, 2018

1. ROLL CALL, INVOCATION AND FLAG SALUTE

Mayor Cicala called the meeting to order at 5:00 p.m.

Also Present: Township Manager Tucci, Township Attorney Zielinski, Township Clerk Stutz

The flag salute was led by Mayor Cicala.

Mayor Cicala made the required announcement concerning the Open Public Meetings Act as follows: Adequate notice of this meeting was duly provided to the Verona-Cedar Grove Times and the Star Ledger on November 21, 2018, filed with the Township Clerk, and posted on the public bulletin board in the Municipal Building Lobby in accordance with the Open Public Meeting Act.

5. MEETING OPEN TO RESIDENTS OF THE TOWNSHIP WISHING TO BE HEARD ON ANY ITEM ON THE AGENDA

Mayor Cicala opened this portion of the meeting to anyone wishing to be heard on any item on the agenda. There being no one present wishing to be heard, Mayor Cicala closed this portion of the meeting.

6. REPORTS OF TOWNSHIP OFFICIALS

a) Township Manager – The Manager provided a report concerning restricted parking along Route 23. The Manager explained that the State has first jurisdiction and municipal ordinance regarding restrictions must coincide and cannot occur until completion of State roadway improvements. Mr. Tucci also provided recommendation from Finance Director to decline waiver of water/sewer penalty fees (Acct. #2-1500007 & 2-1500008), to which the governing body concurred.

b) Township Clerk – The Clerk provided memos regarding annual re-appointment of Township officials and expiring term board/committee members. There was consensus to schedule interviews for expiring term board/committee members for executive session 12/17 at 6:00 p.m.

c) Township Attorney – The Township Attorney discussed the proposed resolution concerning global boycott, divestment and sanctions movement. Attorney Zielinski noted that the draft resolution was forwarded to local rabbi for review. Attorney Zielinski recommended that the resolution should be removed from agenda, pending response, to which the governing body agreed.

d) Other Reports

Councilman Tanella noted the Township of Verona's acquisition of property for intended affordable housing development. Councilman Tanella expressed concern regarding potential traffic impact on Harper Terrace resulting from a proposed development on Commerce Road property in Verona and roadway extension to provide additional ingress/egress via Cedar Grove. The Manager explained that the municipal roadway portion of concern exists on paper only. Mr. Tucci also explained the procedure to eliminate the use of such streets. Following further discussion, the Manager offered to provide a list of "paper streets" that could potentially be vacated.

Deputy Mayor Vargo suggested the possibility of developing a Township community/recreation center. Councilman Tanella commented that funding and location are prime concerns. Councilman Tanella further commented that such an undertaking should be put to the residents for consideration in the form of a public question. Councilman Tanella also noted the potential closure of the Essex County Public Safety Academy and suggested that the Township

correspond with the County Executive to express the Township's interest in potential property acquisition. Mayor Cicala noted taxpayer concerns, and commented that the Board of Education has concerns regarding potential school expansion costs and subsequent bond referendum resulting from development of Hilltop property. Mayor Cicala suggested that the Council host a joint meeting with the Board of Education to discuss funding concerns and taxpayer impact. The Township Manager commented that such discussion is pre-mature at this time, as there is no factual data available yet regarding increased student enrollment from unit sales.

Councilwoman Peterson advised that the Municipal Alliance sponsored "Hidden in Plain Sight" program had to be re-scheduled because of inclement weather. Councilwoman Peterson also commended the Township's response to the recent November snow event, including the Ambulance & Rescue Squad. The Township Manager suggested that residents remember to donate to the A&RS, a volunteer organization.

Mayor Cicala suggested that the Council host a joint meeting with the Board of Education at the end of January/beginning of February 2019, to which the governing body concurred. The Manager was requested to contact the Supt. of Schools to identify specific date(s). Mayor Cicala stated that he attended the grand opening ceremony of Urgent Care. Mayor Cicala further noted that the new business is interested in partnering with the community on projects.

7. NEW BUSINESS

- a) To consider introduction of Pending Ordinance #18-836 – Police Salaries, Grades, Wages and Fees for fiscal years 2019, 2020, 2021 and 2022

**RESOLUTION SUPPORTING THE DRIVE SOBER OR GET PULLED OVER
2018 YEAR END HOLIDAY CRACKDOWN**

WHEREAS, impaired drivers on our nation's roads killed 10,874 people in 2017; and

WHEREAS, 20% of motor vehicle fatalities in New Jersey are alcohol-related; and

WHEREAS, an enforcement crackdown is planned to combat impaired driving; and

WHEREAS, the season at the end of the year is traditionally a time of social gatherings which often include alcohol; and

WHEREAS, the State of New Jersey Division of Highway Traffic Safety, has asked law enforcement agencies throughout the state to participate in the *Drive sober or Get Pulled Over Year End Holiday Crackdown*; and

WHEREAS, the project will involve increased impaired driving enforcement from December 7, 2018 through January 1, 2019, and

WHEREAS, an increase in impaired driving enforcement and a reduction in impaired driving will save lives on our roadways.

NOW THEREFORE BE IT RESOLVED that the Township Council of the Township of Cedar Grove, Essex County, New Jersey, declares its support for the *Drive Sober of Get Pulled Over 2018 Year End Holiday Crackdown* from December 7, 2018 through January 1, 2019 and pledges to increase awareness of the dangers of drinking and driving.

- j) To consider resolution concerning Global Boycott, Divestment and Sanctions Movement

The following resolution had been posted on the bulletin board, and a brief synopsis was given by the Township Clerk:

**RESOLUTION CONDEMNING ALL EFFORTS TO DELEGITIMIZE THE
STATE OF ISRAEL AND THE GLOBAL MOVEMENT TO BOYCOTT, DIVEST
FROM AND SANCTIO THE PEOPLE OF ISRAEL**

WHEREAS, the Global Boycott, Divestment and Sanctions Movement (BDS) is a campaign seeking to exclude the Israeli people from the economic, cultural, and academic life of humanity; and

WHEREAS, this movement targets not just the Israeli government but Israeli academic, cultural, and civil society institutions, as well as individual Israeli citizens of all political persuasions, and in some cases even Jews of other nationalities who support Israel; and

WHEREAS, the Global BDS Movement targets Israel and only Israel, while ignoring the world's myriad despotic regimes; and

WHEREAS, Israel is far and away the most democratic and open society in the Middle East, with well-established rights for religious minorities, women, and all citizens that far exceeds those of any other nation in the region; and

WHEREAS, the Global BDS Movement does not recognize the right of the Jewish people to national self-determination; and

WHEREAS, some of the BDS Movement's supporters and leaders have trafficked in unacceptable anti-Semitic rhetoric, including comparison of Israeli policy to that of Nazi Germany; and

WHEREAS, university-based BDS efforts violate the core goals of the university and global cultural development, which thrive on a free and open exchange and debate; and

WHEREAS, bot Israelis and Palestinians have the right to live in safe and secure states, free from fear; and

WHEREAS, both Israelis and Palestinians have the right to live in safe and secure states, free from fear and violence, with mutual recognition; and

WHEREAS, the Global BDS Movement does not support the two-state solution, a goal which can only be reached through direct negotiations between Israel and the Palestinians; and

WHEREAS, Israel is an ally of the United States and has a long-standing relationship with the City of New York; and

WHEREAS, our local region has the largest population of Jewish residents in the nation and is home to the largest Jewish community outside of Israel.

NOW, THEREFORE BE IT RESOLVED that the Township Council of the Township of Cedar Grove condemns all efforts to delegitimize the State of Israel and the global movement to boycott, divest from, and sanction its government and people.

There was consensus to table resolution pending input from Rabbi Groffman of Temple Shalom.

1. The Township Manager is hereby authorized and directed to execute an agreement with Boswell Engineering of South Hackensack, New Jersey, for an amount not to exceed \$ 4,400.00 in accordance with the proposal dated November 9, 2018.
2. This agreement is awarded as a “Professional Service” in accordance with 40A:11-5(1)(a) of the Local Public Contracts Law because of the technical nature of the professional services required for this project; and
3. A notice of this agreement shall be published in the Verona-Cedar Grove Times as required by law.
