a) Township Manager – The Township Manager congratulated the Mayor on his re-election. He congratulated Councilman-Elect Zazzali and Councilwoman Mega. He reported he had the honor of swearing in Councilwoman Mega who he had seen serve the community. The Township Manager reported Anderson Parkway was completely repaved. The Township Manager reported he was currently considering two new NJDOT grants. The Township Manager reported the cupola was 98% completed and came in under budget and ahead of time. The Township Manager reported the pickleball courts on Little Falls Road were restriped. The Township Manager reported the RFP for Little Falls Basketball Court would be posted in two weeks. The Township Manager reported there were six plots left in the community garden and asked interested residents to email him.

# d) Other Reports

Councilwoman Skabich – No report. Councilwoman Skabich welcomed and congratulated Councilwoman Mega on her election and shared she was thrilled to sit on Council with her. Councilwoman Skabich congratulated Mayor Maceri and shared she looked forward to serving with him for the next four years. Councilwoman Skabich shared it was Councilman Tanella's last public meeting and she was honored to sit on Council with him. Councilwoman Skabich said Eagle Scout Robyn Ulrich made an amazing accomplishment. Councilwoman Skabich said she pushed for the community garden and was lucky enough to be one of the folks who got a bed. Thanked the volunteers who got it ready for the public to enjoy. She encouraged the public to contact Manager Zichelli if they wanted a spot.

Councilman Tanella – No Report. Councilman Tanella said he knew Councilwoman Skabich pushed for a community garden which would serve the community for a long period of time. Councilman Tanella congratulated Mayor Maceri and Councilwoman Mega on their re-election and election respectively. He said Councilwoman Mega would serve the community well from this side of the aisle. He congratulated Councilman-Elect Zazzali on his election.

## Councilwoman Mega made the following remarks:

Thank you to our Cedar Grove Recreation Department, Cedar Grove Police Department and DPW for the Memorial Day Parade which several organization and volunteers from Cedar Grove participated in. Of course, thank you to the residents out there who were cheering on our parade walkers. This past weekend, we had our 32<sup>nd</sup> Annual Clean Sweep event which again several organizations and volunteer groups from town participated in and it was another successful event. Thank you to all involved. I thank the community again for voting me into this role and I look forward to working with the Township Manager, the Mayor and Council serving Cedar Grove the best I possibly can. A real special thank you to Councilman Tanella."

Mayor Maceri – Mayor Maceri reported during Clean Sweep, the DPW already had the Town in tip-top shape. He thanked and acknowledged the hard work of all of the workers

of the DPW. The Mayor congratulated Councilwoman Mega on her election. He shared it was a pleasure campaigning with her and he looked forward to working with her on Council. The Mayor congratulated Councilman-Elect Zazzali and he looked forward to working with him as well.

**WHEREAS**, the Township Council deems it in the best interest of the Township to promote Christopher Tufaro to fill the vacant term existing for the position of Tax Collector;

**NOW, THEREFORE, BE IT RESOLVED**, that the Township Council of the Township of Cedar Grove hereby authorizes the Township Manager to offer a promotion to Christopher Tufaro as Certified Tax Collector of the Township of Cedar Grove.

**WHEREAS**, Phil and Jean Jaeger present their knowledge through authored books and regular newsletters; and

**WHEREAS**, The Cedar Grove Historical Society and the Township of Cedar Grove have benefited from their membership, leadership, and participation; and

**WHEREAS**, Phil and Jean Jaeger's volunteer service to the Township is a cornerstone upon which Cedar Grove history will be preserved; and
