WHEREAS, it has been determined that certain changes and modifications were needed, and

WHEREAS, Change Order 1 increases the amount of the contract by \$12,000.00 which is 3.1% more than the original contract award; and

WHEREAS, Change Order 2 increases the amount of the contract by \$2,100.00 which is 0.6% more than the original contract award; and

WHEREAS, Change Order 3 increases the amount of the contract by \$15,000.00 which is 3.9% more than the original contract award; and

WHEREAS the Maintenance Bond has now been received, reviewed, and approved by the Township Attorney; and

NOW, THERFORE BE IT HEREBY RESOLVED that the Township Council of the Township of Cedar Grove hereby authorizes the Change Order Nos. 1, 2 & 3 increasing the contract in the amount of \$29,100.00 for a total not to exceed \$418,700.00.

BE IT FURTHER RESOLVED that the Township Council of the Township of Cedar Grove hereby accepts Maintenance Bond No. 100001388 which is on file in the Office of the Township Clerk, and herby authorizes the release of Performance Bond No. 100001388 as well as the release of Labor & Materials Bond 100001388 and that the final payment is hereby authorized to be released.

WHEREAS, the Governor's Council on Alcoholism and Drug Abuse established the Municipal Alliance for the Prevention of Alcoholism and Drug Abuse in 1989 to educate and engage residents, local government and law enforcement officials, schools, nonprofit organizations, the faith community, parents, youth and other allies in efforts to prevent alcoholism and drug abuse in communities throughout New Jersey.

WHEREAS, the Township Council of the Township of Cedar Grove, County of Essex, State of New Jersey recognizes that the abuse of alcohol and drugs is a serious problem in our society amongst persons of all ages; and therefore has an established Municipal Alliance Committee; and,

WHEREAS, the Township Council further recognizes that it is incumbent upon not only public officials but upon the entire community to take action to prevent such abuses in our community; and,

WHEREAS, the Township Council has applied for funding to the Governor's Council on Alcoholism and Drug Abuse through the County of Essex.

NOW, THEREFORE, BE IT RESOLVED by the Township of Cedar Grove, County of Essex, State of New Jersey hereby recognizes the following:

1. The Township Council does hereby authorize submission of a strategic plan for the Cedar Grove Municipal Alliance grant funding for period July 1, 2024 to June 30, 2025 in the amount of:

WHEREAS, a contract was awarded by the Township Council at a meeting held on March 20, 2023 to American Asphalt & Trucking LLC for the Reconstruction of Anderson Parkway in the amount of \$304,631.86 Agenda Item #7(A); and

WHEREAS, it has been determined that certain changes and modifications were needed, and

WHEREAS, Change Order 1 decreases the amount of the contract by \$22,519.68 which is 7.39% less than the original contract award; and

WHEREAS, Change Order 2 decreases the amount of the contract by \$1,778.41 which is 7.98% less than the original contract award; and

WHEREAS, the Maintenance Bond has been received, reviewed, and approved by the Township Manager.

NOW, THERFORE BE IT HEREBY RESOLVED by the Township Council of the Township of Cedar Grove hereby authorizes Change Order No. 1 and Change Order No. 2, which decreases the contract in the amount of \$24,298.09 for a total not to exceed \$280,333.77.

BE IT FURTHER RESOLVED by the Township Council of the Township of Cedar Grove hereby accepts Maintenance Bond No. CSC-229327M which is on file in the Office of the Township Clerk and that the final payment is hereby authorized to be released.

The Township Manager reported there was a reduction in cost in the amount budgeted for this project.
