a) To consider resolution authorizing the execution of a consulting contract with Holman, Frenia Allison, P.C. for purposes of transitioning financial software.

The following resolution had been posted on the bulletin board, and a brief synopsis was given by the Township Clerk:

RESOLUTION AUTHORIZING THE EXECUTION OF A CONSULTING CONTRACT WITH THE FIRM HOLMAN FRENIA ALLISON, P.C. ("HFA") FOR PURPOSES OF TRANSITIONING FINANCE SOFTWARE

**WHEREAS**, the Township appointed Rebecca Roth, CMFO, CTC, QPA, RMC as the Township's Chief Financial Officer effective November 13, 2023; and

WHEREAS, the prior need to have a private firm perform municipal finance duties is no longer required due to the appointment of Rebecca Roth, CMFO, CTC, QPA, RMC; and

**WHEREAS**; the Township has terminated the prior professional services contract previously entered into by and between the Township and HFA dated August 8, 2023 because of the appointment of Rebecca Roth, CMFO, CTC, QPA, RMC; and

**WHEREAS**, the Township has introduced and passed Capital Ordinance #23-919, appropriating \$100,000 in funds for the implementation of Edmunds Finance Software in the Finance Office; and

**WHEREAS**, the general unfamiliarity with the Township's current finance software, GFMS, would make the software transition difficult without consultative assistance from HFA, a firm familiar the operations of both GFMS and Edmunds; and

WHEREAS, the Division of Local Government Services ("DLGS") has reviewed this temporary consulting contract without objection; and

WHEREAS, HFA is willing to render such services to the Township; and

WHEREAS, the Township intends to award a professional services contract to HFA for an amount not to exceed fifty thousand dollars (\$50,000) to perform transitory software consulting while the Township moves from GFMS to Edmunds Finance Software.

**NOW, THEREFORE, BE IT RESOLVED** by the Township Council of the Township of Cedar Grove, in the County of Essex, State of New Jersey, that the Township Manager is hereby authorized to execute the professional service contract with HFA for providing transitory software consulting services for a term not to exceed six (6) months.

The Township Manager reported HFA, formerly contracted as the CFO, would transfer the financial software from GFIS to Edmunds.

**WHEREAS**, Rebecca M. Roth holds the certification of Qualified Purchasing Agent (QPA) issued by the Director of the Division of Local Government Services of the State of New Jersey; and

**WHEREAS**, the Local Public Contracts Law, N.J.S.A. 40A:11-1, et seq. permits the local contracting unit to have a bid threshold up to \$44,000 and a quote threshold of 15% of the bid threshold (\$6,600) with the designation of a Qualified Purchasing Agent; and

WHEREAS, pursuant to N.J.S.A. 19:44A-20.4 and 20.5, the Governing Body may delegate authority to the Qualified Purchasing Agent to award contracts having an anticipated value in excess of \$17,500 but below the municipality's bid threshold; and

**WHEREAS**, the Township Council desires to authorize the Qualified Purchasing Agent to award contracts up to the Township's bid threshold;

**NOW THEREFORE BE IT RESOLVED** by the Township Council of the Township of Cedar Grove, County of Essex, State of New Jersey, that Rebecca M. Roth is hereby appointed as Qualified Purchasing Agent for the Township of Cedar Grove, increasing the bid threshold

to \$44,000, and authorizing the Qualified Purchasing Agent to award contracts up to the Township's bid threshold.

The Township Manager reported the bid threshold would increase from \$17,500.00 to \$44,000.00.

**WHEREAS**, pursuant to N.J.S.A. 40A:11-2 (39) and N.J.A.C. 5:34-9.1, proprietary services are that of a specialized nature, in which the good or services that will be used has such unique characteristics that only the goods or services of a single vendor are capable of meeting the contracting unit's needs; and

**WHEREAS**, services such as support and/or maintenance of proprietary hardware and software may be awarded without competitive bidding pursuant to N.J.S.A. 40A:11-5(dd); and

**WHEREAS**, the Township Council adopted Ordinance #23-919 on November 6, 2023 appropriating \$100,000 in funds for this software; and

**WHEREAS**, there will be sufficient funds in the Capital Budget for the procurement of this software.

**NOW, THEREFORE, BE IT RESOLVED** by the Township Council of the Township of Cedar Grove hereby awards a contract to Edmunds & Associates, Inc., 301A Tilton Road, Northfield, NJ 08225, for the purchase of financial, tax, utility software in an amount not to exceed \$73,450.00.
